

Carroll Township Recycles

Requirements of the Carroll Township Mandatory Recycling Program:

RESIDENTIAL RECYCLING

- All residents **MUST** have curbside garbage & recycling service through the Township's contracted hauler which is Penn Waste, Inc. (717-767-4456) through 2019.
- **MATERIALS to be RECYCLED (required):**
 - => **Glass** (clear, green & brown bottles & jars) - prepare by rinsing & discarding lids
 - => **Aluminum & Steel Cans** - prepare by rinsing
 - => **Plastic Containers** (#1 - #7) - prepare by rinsing & discarding lids
 - => **Mixed Papers, Newspaper & Cardboard** - prepare by keeping dry & flattening cardboard
 - => **Leaf Waste** (leaves, shrubbery, tree trimmings, garden residues & other yard wastes, NO grass clippings) - Penn Waste pick up May through November the 1st Saturday of the month. Year round drop off at Township Leaf Waste Facility. Must apply for a key card at the Township Office. Backyard composting is also acceptable.
- **COLLECTION:** Commingled recyclables (glass, aluminum & steel cans, plastic containers & mixed papers, newspapers & cardboard) will be collected curbside by the contracted hauler weekly.
- **CONTAINERS:** Recycling containers are available to residents at the Carroll Township office at no charge.
- **BURNING:** Burning of trash and recyclables is prohibited. Ordinance No. 2014-230
- **ENFORCEMENT:** Persons found violating the recycling program/ordinance will be subject to the enforcement policy, which includes fines up to \$1,000.00 per day of violation.
- **EDUCATION:** Education is circulated on a regular basis whether by annual direct mailings, flyers/inserts in trash bills, various information available at the Township building, information on the Township website & welcome packets for new residents through the Community Greeter.

COMMERCIAL RECYCLING

- All businesses **MUST** have curbside garbage & recycling service through a garbage hauler of your choice. Exempt from curbside service if recycling of designated materials is otherwise provided for.
- **MATERIALS to be RECYCLED (required):**
 - => **Glass** (clear, green & brown bottles & jars) - prepare by rinsing & discarding lids
 - => **Aluminum & Steel Cans** - prepare by rinsing
 - => **Plastic Containers** (#1 - #7) - prepare by rinsing & discarding lids
 - => **Mixed Papers, Newspaper & Cardboard** - prepare by keeping dry and flattening cardboard
 - => **Leaf Waste** (leaves, shrubbery, tree trimmings, garden residues & other yard wastes, NO grass clippings) - Discuss options with your garbage hauler of choice. Year round drop off at Township Leaf Waste Facility. Must apply for a key card at the Township Office. Composting is also acceptable.
- **COLLECTION:** Commingled recyclables (glass, aluminum & steel cans, plastic containers & mixed papers, newspapers & cardboard) shall be collected by the garbage hauler of your choice a minimum of once per month.
- **CONTAINERS:** Discuss options with the garbage hauler of your choice.
- **BURNING:** Burning of trash and recyclables is prohibited. Ordinance No. 2014-230
- **ENFORCEMENT:** Persons found violating the recycling program/ordinance will be subject to the enforcement policy, which includes fines up to \$1,000.00 per day of violation.
- **EDUCATION:** Education is circulated on a regular basis whether by annual direct mailings, flyers/inserts in trash bills, various information available at the Township building & information on the Township website.
- **REPORTING:** Annual Commercial Recycling Report, with the amount & type of recyclables collected each year, sent before February 1st of the following year to the Carroll Township Office. Form is available on our website.

ADDITIONAL RECYCLING PROGRAMS: We also support York County Solid Waste Authority's Household Hazardous Waste, Electronics, and Litter & Illegal Dump Clean-up Programs.
