Following are the meeting minutes from the Zoning Hearing Board (ZHB) business meeting held on Jan 27th, 2025 at 6:00pm at the Carroll Township offices:

- 1. Everyone stood to recite the Pledge of Allegiance.
- 2. Chairman Reihart started the meeting announcing the requirement to perform the annual Board reorganization for 2025:
 - a. A motion was made for Gary Reihart to be appointed Chairman of the ZHB. The motion was seconded and passed unanimously.
 - b. A motion was made for Rich Gensler to be appointed Vice-Chairman. The motion was seconded and passed unanimously.
 - c. A motion was made for Frank Setlak to be appointed Secretary. The motion was seconded and passed unanimously.
 - d. A motion was made for John R. Wilson of CGA Law Firm to be appointed Solicitor. The motion was seconded and passed unanimously.
 - e. A motion was made for all ZHB members to be appointed as Hearing Officers. The motion was seconded and passed unanimously.
 - f. A motion was made for the ZHB meetings be held on the 4th Monday of each month at 6:00pm as requested. The motion was seconded and passed unanimously.
 - g. A motion was made for Roxy Cressler to be appointed Hearing Stenographer. The motion was seconded and passed unanimously.
- 3. A motion was made to accept the Nov 25th, 2024 ZHB business meeting minutes into record. The motion was seconded and passed unanimously.
- 4. The business meeting was recessed to commence with the hearing for Special Exception request 2025-001.
- 5. The hearing portion of the meeting was adjourned to continue with the business meeting.
- 6. Board member Setlak provided the Board with an updated expense report for 2024. There were no questions regarding the report (attached). Setlak stated that there were two more

invoices to be recorded for 2024 and he would update the report to be sent with the meeting minutes.

- 7. The Board moved into an Executive Session to review and discuss the pending land use appeal in York County Court of Common Pleas.
- 8. After the Executive Session ended the Board discussed the conflicting language in the zoning ordinances that came up in the hearing this evening. It was regarding the maximum height of a building in a zoning district vs. allowances for certain development, in this case, a religious facility. Article 450-105 describes that the greater restriction applies when the zoning ordinances conflict. The Board made a motion which was seconded, and unanimously passed to have Solicitor Wilson perform some research on the entire language in 450-105 to assist and better guide the Zoning Officer and the Board in decisions regarding ordinance conflicts. Mr. Wilson is to submit his findings and suggestions to Brandon Slatt and the Board.
- 9. A motion was made to adjourn the meeting, which was seconded, and unanimously passed.
