APPOINTMENT OF TOWNSHIP SOLICITOR It was moved by Supervisor Trostle, seconded by Supervisor Moyer-Schwille, to re-appoint Stone, Wiley & Linsenbach, PC, Duane Stone, Esquire, as Carroll Township's Solicitor at the rate of \$165.00 per hour for everything except litigations, and \$185.00 per hour for litigations for 2022. Motion did not carry.
