SWEARING IN TOWNSHIP MANAGER Brandon Slatt, Township Manager, was sworn in to give a brief summary on the proposed Ordinance Number 2023-255. He testified as to the purpose of the change and reasons that he believes that the change would be appropriate. He stated that the applicant would be required to send out by certified mail ten days prior to the Planning Commission meeting notifying the property owners of the meeting and the plan submittal. The applicant would have to post the property with a physical sign at least nine square feet in size that has the notification with relative information with regards to the project. The posting shall be seven days prior to the plan submission to the township.

Mr. Dethlefs asked Brandon Slatt, Township Manager, if he would like the court reporter to attach Exhibits B-1 and B-2 to the transcript. Mr. Slatt stated yes.
