CALL TO ORDER

Chairman Kelly called the regularly scheduled Work Session of the Carroll Township Board of Supervisors to order at 6:41 p.m. The location of the meeting is the Carroll Township Municipal Building, 555 Chestnut Grove Road, Dillsburg, Pennsylvania.

PUBLIC COMMENTS Chairman Kelly called for public comments. There were no comments.

ITEMS TO BE PLACED ON THE NOVEMBER 13, 2023 AGENDA The following items were discussed and are to be placed on the November 19, 2023, Board of Supervisors Meeting Agenda for further discussion and for action:

1. Drawing for Final Land Development Plan for 54 Old York Road – Devspire LLC – Deadline date December 31, 2023.

Phillip Brath, Township Engineer, stated a Form 301 Driveway Agreement will be needed for the type of paving they are putting down.

2. Preliminary/Final Mixed Used Development 15 Ore Bank Road – Inch's Property – Deadline date November 20, 2023 – Time Extension needed and/or plan approval.

Supervisor Moyer-Schwille questioned the proposed public road request. Are they still planning on dedicating the roads to the Township.

Phillip Brath stated that the developer has softened the curve on Ore Bank Road. He is also working with the developer across the street. He also stated that the developer will be contributing 33% to the cost of the roundabout project and that will be a condition before recording the plan.

Joe Eisenhauer stated they are ready with the single-family homes. The builder is ready to go. They are also ready to go with the commercial parcels.

3. Preliminary/Final Land Development Plan Middle & Elementary School Campus Improvements for Northern York County School District – Deadline date January 26, 2024

Jessica Baim stated that she is concerned about the drop off area for the High School and Middle School.

Linda Fiscus recommended that they move the tennis courts and use this area for traffic.

- 4. Update Proposed amendments to the Carroll Township Subdivision and Land Development Ordinance to add the Developer must notify the surrounding property owners by certified mail when a plan is submitted for approval. The Carroll Township Planning Commission at their October 26, 2023, meeting recommended that the Board advertise and adopt the proposed amendments. Set the public hearing date and authorize the advertisement of the proposed Ordinance Number 2023-255.
- 5. Authorize to go out for RFPs for a Planner for the Comprehensive Plan Revisions.
- 6. Resolution Number 2023-18 to adopt Northside Court as a Township Road, set 18-Month Maintenance Bond, and request to release financial surety.

Michael Pykosh, Township Solicitor, stated that a letter will be needed stating that the property is clear of all liens.

- 8. Final Subdivision Plans for Harold C. Willis Time extension to record the plan until December 31, 2023.
- 9. Paytime Proposal outsource payroll for 2024.
- 10. Permission to advertise the 2024 Proposed Budget.
- 11. Disposal rates at the York County Resource Recovery Facility are increasing by \$7.00 per ton effective January 01, 2024. Carroll Township's rate will increase by \$1.70 per quarter. This will increase the quarterly rate to Carroll Township residents from \$87.07 per quarter to \$88.76 per quarter effective January 01, 2024. The low volume bag service customers will not have an increase.

Scott Vance stated the sidewalk in Stonebridge Phase I are degrading and some are rising up. He also questioned when will the Comprehensive Plan and Traffic Study be done.
