Supervisor Wall stated we should remove the Richwine property from the Comp Plan since they requested it to be removed. She also feels that any references to South Mountain Trolley and all public comments should be removed.

Chelsie Markle – 151 Quail Drive – feels the comments listed in the Comp Plan are from the surveys received and should not be

removed. Also feels the Richwine property should not be removed.

Supervisor Bush asked how much did the comp plan cost. He feels the advertisements, all references to the South Mountain Greenway Trolley, and public comments should be removed from the Comp Plan. He stated that the Cumberland Valley Railway from Mechanicsburg to Dillsburg, 25 years later the land was converted back to the original property owners.
