She questioned whether the Board is looking into the Subdivision and Land Development Ordinance to address Data Centers, the noise, use of water, and other issues pertaining to this matter.

Brian Pinamonti – 1110 Grouse Road – stated he is concerned about the truck traffic on Grouse Road. Dillsburg Borough restricts the trucks from South Baltimore Street to Wargo Lane. He is asking the Board to restrict trucks from Old York Road to Wargo Lane.

Vicky Church – 17 Ashley Drive – asked the Solicitor who really owns the park. She is also concerned about the six-foot fence installation along the railroad tracks that is required by the Township Liability carrier.

Mike Pyskosh – Township Solicitor – stated that the deeds show that the developer transferred the property to the Berkshire Hills Civic Association and if the Association would fold the property would come back to the Township. But the Township does not have to take it.

Sheila Covert – 1163 Park Avenue – questioned if the fence would be installed in the electric easement.
