APPROVAL OF THE SEPTEMBER 12, 2022 MINUTES It was moved by Supervisor Moyer-Schwille, seconded by Supervisor Wall, and unanimously carried to approve the September 12, 2022 Board of Supervisors Meeting Minutes as submitted.

RESOLUTION NUMBER 2022-15 STONEBRIDGE CROSSING PHASE I STREET DEDICATION It was moved by Supervisor Sailhamer, seconded by Supervisor Moyer-Schwille to adopt Resolution Number 2022-15

– A Resolution of the Board of Supervisors of Carroll Township, York County, Pennsylvania to accept the street dedication of a Portion of Stonebridge Drive, Graystone Court, Hearthstone Court, and Cobblestone Way for the Stonebridge Crossing Phase I Development and pay the Liquid Fuels fee of \$3,327.48.

It was moved by Supervisor Sailhamer, seconded by Supervisor Moyer-Schwille, and unanimously carried to release \$379,091.02 from the financial surety being held for improvements completed in the Stonebridge Crossing Phase 1 development on Lexon Surety Group Bond No. 1012872. This will reduce the surety for this project from \$399,091.02 to \$20,000.00. The Twenty thousand dollars (\$20,000.00) is being held for the E & S for the stormwater basin conversion until the NPDES permit is closed.. There will be a \$135,710.23 Maintenance Bond required for 18 months.

RESOLUTION NUMBER 2022-25 DILLSBURG VENTURES APPROVING THE CONCEPTUAL SITE PLAN 18B.4 It was moved by Supervisor Sailhamer, seconded by Supervisor Bush, and unanimously carried to adopt Resolution Number 2022-25 – A Resolution approving a modified sketch plan (Conceptual Site Plan 18B.4) for Village at South Mountain for Dillsburg Ventures, LLC pursuant to a settlement Agreement dated December 10, 2018.

Phillip Brath, Township Engineer, stated that the Developer must still address the following items:

- 1. Need to address the townhomes parking must be one inside and two outside on each dwelling. The parking did increase to three spaces/dwelling unit.
- 2. Apartments at the top of the hill are shown as three-story apartments. We are going to hear more about this.

NEW PROPOSED FUTURE POLICE DEPARTMENT Kelly Wall stated that she and Brandon met with Lee Eichelberger concerning the proposed future New Police Department Building on Old York Road. This project will be a lease to own. This building will house the Carroll Township Police Department, Northern York County Fire Rescue, Magisterial District Court 19-3-10, and York County Probation. The next step would be to hire grant writers.

It was moved by Supervisor Sailhamer, seconded by Supervisor Bush, and unanimously carried to move forward with the proposed future New Police Department Building on Old York Road and look into hiring grant writers for this project.
