The following residents of Windy Heights Phase III have concerns about the conditions of their properties:

Janice Buffington – 222 Eagle Road – stormwater issues & not being able to grow grass. She sent a letter to the developer listing all of the inside items that needed addressed and all the outside items that needed addressed. She also stated the property is not graded as per the plan. She has spent a lot of money to grow grass.

Sheila Covert – 1163 Park Avenue – stormwater issues & not being able to grow grass. She had serval loads of topsoil delivered and still can't grow grass.

Sandra Eimer – 300 Normandy Lane – stormwater issues

Mark DeSouza – Windy Heights Developer – stated that all issues were addressed. He did not receive a list from Phil Brath or Brandon Slatt. The street and concrete issues were fixed and inspected three times. The sidewalk issue between 300 and 203 Eagle Road has been fixed. Basins 3 and 4 were converted and will be inspected here in September. He also stated that each lot has 4" of topsoil. They have met or exceeded the requirement.

Ken Farner – 385 Ore Bank Road – stated he has concerns about this development. The 4" of topsoil where did the topsoil come from. Can't grow grass in stones.
