ADOPTION OF 2025 CARROLL TOWNSHIP & DILLSBURG BOROUGH MULTI-MUNICIPAL COMPREHENSIVE PLAN

WHEREAS, Carroll Township and Dillsburg Borough face many planning challenges such as population growth, increased traffic, new residential and non-residential development, economic longevity and the preservation of open space and the protection of natural resources; and

WHEREAS, Carroll Township and Dillsburg Borough held public meetings on April 4 and December 5, 2024, and April 9, 2025; and

WHEREAS, the Carroll Township Planning Commission held a public meeting on May 22, 2025; and

WHEREAS, Carroll Township and Dillsburg Borough submitted the Carroll Township & Dillsburg Borough Multi-Municipal Comprehensive Plan to York County at least 45 days prior to holding advertised Public Hearings, and forwarded copies of the Comprehensive Plan to all contiguous municipalities and the Northern York County School District for review and comment; and

WHEREAS, the Carroll Township Board of Supervisors has considered review comments of the County, contiguous municipalities, and the School District, as well as public meeting comments and recommendations of the Carroll Township Planning Commission; and

WHEREAS, the Carroll Township Board of Supervisors held a public hearing for the Comprehensive Plan on September 08, 2025 and October 13, 2025; and

WHEREAS, the Carroll Township & Dillsburg Borough Multi-Municipal Comprehensive Plan was prepared in accordance with the Pennsylvania Municipalities Planning Code, Section 301, and was advertised, presented at public meetings, and distributed to York County and contiguous municipalities in accordance with the Pennsylvania Municipalities Planning Code, Section 302; and

WHEREAS, Carroll Township states that it is neither affiliated with nor endorses any of the entities referred to in this Multi-Municipal Comprehensive Plan.

NOW, THEREFORE BE IT RESOLVED, that the Carroll Township Board of Supervisors hereby adopts the Carroll Township & Dillsburg Borough Multi-Municipal Comprehensive Plan, dated October 2025, in its entirety.


