## Fire Department News

As a property owner in Carroll Township, you may have noticed a new tax included with your spring tax bill. Resolution 2022-17 was passed by the Board of Supervisors in May of 2022. This Resolution established a tax for the purpose of providing fire services within the Township starting in 2023. The Board recognized the need for funds to sustain fire services since, donations alone, were not enough to maintain the operation of the department. A millage rate was established in the amount of .590 mills (\$0.059 per \$100.00) to fund these services. It is a priority of the Township to secure and maintain fire protection services for our residents. The collected money from this once-a-year tax will be used for, but not limited to, purchasing and maintaining fire apparatus, training of fire company personnel, and making appropriations to fire companies serving Carroll Township.

### A message from Northern York County Fire Rescue

The Officers and Members of Northern York County Fire Rescue take great pride in protecting the residents we serve. Together, working with each municipality we serve, we have improved our relationship by continuously having open lines of communication. This has led to some great changes that we are very proud of. In October of 2022 we added a paid crew during the daylight hours of Monday through Friday. While most of our volunteers work during these hours and with the increased growth in our area, it was becoming very apparent that something needed done. The fire department has hired nine highly experienced firefighters to protect our first due area during the daylight hours. This has been a great success as no calls have been missed. Recently the department has ordered a new fire truck. This comes from developing a program to replace our fleet as it ag-

es, which was becoming less effective and costly. Looking to the future, we have started a junior firefighter program to develop young energetic persons wanting to become firefighters and contribute to the community. This has also been very successful with an increase in young members. Northern York County Fire Rescue would like to thank everyone for their continued support.

### **RECYCLING GUIDELINES**

### **METAL**

- Aluminum beverage cans
- Steel and bi-metal food & beverage cans
- √ Rinse thoroughly to ensure they are free of contaminants and residue.
- √ Remove caps or lids and dispose of them in the trash.
- √ It is not necessary to remove labels.



### **GLASS**

- Clear, blue, brown and green glass food & beverage containers
- √ Rinse thoroughly to ensure they are free of contaminants and residue.
- √ Remove caps or lids and dispose of them in the trash.
- √ It is not necessary to remove labels and neck rings.



### **PLASTICS**

- Plastic containers #1, #2 and #5 with a neck smaller than the base
- √ Rinse thoroughly to ensure they are free of contaminants and residue.
- √ Remove caps or lids and dispose of them in the trash.
- √ It is not necessary to remove labels and neck rings.



### **NEWSPAPER**

- √ Clean and Dry.
- $\sqrt{\text{No food contact.}}$
- √ Cover loose paper with heavier items in the container to prevent them from blowing.

### **CARDBOARD**

- All sizes of corrugated cardboard and shipping boxes
- √ Dry and flattened.
- √ No food contact.
- √ Bundle any large or loose pieces of cardboard that will not fit in your recycling bin.

### **CARTONS**

- Shelf-stable and refrigerated food and beverage cartons
- √ Remove and dispose of straws and caps in the trash.
- $\sqrt{\text{Rinse cartons.}}$

### **Electronics Recycling**

Under PA Act 108 (the state's Covered Device Recycling Act), it is unlawful for Pennsylvania landfills and resource recovery facilities to accept specific electronic devices (computers, computer peripherals and televisions) for disposal. PA waste haulers are also prohibited from collecting these electronics for disposal. Fairview Township's Electronic Recycling Center is open to all York County residents free of charge. Spring/Summer (April-Oct) hours are Monday—Saturday, 8:00am to 4:30pm except holidays. Fall/Winter (Nov-March) hours are Monday—Friday, 9:00am to Noon and the 1st and 3rd Saturday of every month, from 9:00am to Noon except holidays.

Fairview Township's Electronics Recycling Drop-Off Center is located at 285 Spanglers Mill Road, New Cumberland, PA 17070

Other electronic devices that are accepted at the drop-off include answering machines, CD players, fax machines, computer hard drives, mobile phones, modems, microwave ovens, pagers, small home office copiers, printers, circuit boards, clocks, radios, remote controls, stereos, tape players, MP3 players, electronic toys and games, photo and video cameras, telephones and telephone equipment, VCRs, humidifiers, (no dehumidifiers!), toaster ovens, hair dryers, electric razors, and many other mixed household electronics.



York County businesses, schools and organizations are not eligible to participate in this residential electronics recycling program. Additional information can be found at www.twp.fairview.pa.us.

# Free Household Hazardous Waste Collection Event



This year's event will take place Saturday, May 6th in the York County Solid Waste Authority's paved lot behind the Recycling Drop-off Area located at 2685 Blackthorne Court, York.

Each year on the first Saturday in May, the Authority conducts a **FREE** HHW Collection Event. There is no fee for York County residents to participate, but registration is mandatory.

#### Businesses, organizations and schools are not eligible to participate.

The Authority provides this service as part of our integrated waste management system and through a grant from the Pennsylvania Department of Environmental Protection. After collection, HHW is transported to hazardous waste facilities that safely manage, and whenever possible, recycle the materials collected.

Accepted Items: Driveway Sealant, Flammable Materials (Fuels, Lacquers, Solvents, Wood Stains etc.) Fluorescent Bulbs, Tube Lights and Lighting Ballasts, Garden Chemicals (Fertilizers, Herbicides, Insecticides, etc.) Household Cleaners (Chemical Strippers, Disinfectants, Stain Removers, etc.) Mercury Containing Devices and Liquid Mercury, Photographic Chemicals, Pool Chemical, Rechargeable Batteries (Nickel Cadmium, Nickel Metal Hydride and Lithium Ion) Vehicle Fluids (Antifreeze, Brake Fluid, Motor Oil, etc.)

<u>Unaccepted Items:</u> Alkaline Batteries, Auto (Lead Acid) Batteries, Ammunition and Explosives, Asbestos Containing Products, Fire Extinguishers, Medical Waste and Medications, Pressurized Gas Tanks (Propane, Helium, Oxygen), Paint, Radioactive Materials, Smoke/Carbon Monoxide Detectors.

### **Leaf Waste Drop-off Facility**

The Carroll Township Leaf Waste Drop-off Facility is open year around for disposal of leaf waste. It is located on Sunny Lane behind the Township Maintenance Shed. You must apply for a Key Card to access the facility. Key cards are available for residential, non-residential and landscape/lawn service businesses which reside in the Township. Application forms are available at the Township office and our website www.carrolltownship.com. The applications are processed at the Township office and require a minimum of one day to enter information into the key card system. Cards are free to residents, \$300 to non-residential and \$500 to landscape/lawn service businesses (All accepted materials must originate from Carroll Township). Lost or damaged cards can be replaced for a \$20 fee.

Materials accepted are leaves, twigs, branches, tree trimmings (8' or shorter and 14" or less in diameter), garden residue, and small shrubs. NO grass clippings. All items must be removed from bags. Do not leave bags in the facility. These materials are transported to a PA DEP permitted composting site.

Do not drop-off root balls, skids, treated lumber, telephone poles, railroad ties, bricks, stones, metal, steel, aluminum, furniture, garbage of any type, tires, batteries, construction materials or any other item that is not considered leaf waste. These items can damage the equipment during processing. This facility is monitored by security cameras and anyone who does not abide by the rules could be denied access.

Penn Waste offers an additional option for the recycling of leaf waste. This is a curbside pick up May through November, the first Saturday of the month. Materials such as tree trimmings, shrubbery and other organic landscape vegetation will be collected. Leaf waste needs to be in biodegradable brown paper bags or bundle it with biodegradable twine in easy-to-handle bundles. Bundles may be no longer than 5 feet, weigh no more than 30 pounds and not exceed 6 inches in diameter. In order to ensure collection of your leaf waste on Saturday mornings, please have material curbside Friday evening. An unlimited number of bags or bundles will be taken. Grass clippings, fruit and vegetables, tree stumps and dirt/stones will not be collected. Leaf waste in plastic bags will not be collected.

### LEAF WASTE IS A MANDATORY RECYCLABLE

Home composting is an acceptable form of recycling leaf waste.

# Search Tool for Disposal Options on Various Materials

Where can I dispose of rechargeable batteries? What can I do with an old propane tank? Sooner or later, everyone struggles with this type of question. The York County Solid Waste Authority has a website residential disposal search tool. This is a keyword search to look-up donation, recycling and disposal options for various materials. Information can be reached using multiple names for the same item. The search tool is located on the YCSWA website main homepage and on their homepages of the "Disposal of Waste" and "Recycling" sections. This search tool makes it easier for residents to find an answer to the question "What do I do with this?"

### **Bulk Items**

One bulk item per week that can be lifted by two men will be picked up on your regular trash day. Appliances containing Freon must be pre-scheduled by calling Penn Waste at 717-767-4456. For safety purposes, doors to appliances must be removed. Pay Per Bag customers must attach a Penn Waste trash bag to the bulk item.

### **Acceptable Bulk Items:**

Furniture, washer/dryer, hot water tank, dish washers, mattresses, carpet (4' length rolled/tied), kerosene heaters, lawn mowers, and similar (must have a dry fuel tank and lids removed), automobile tire off the rim (1 per week).

### **Unacceptable Bulk Items:**

Household hazardous waste, chemicals, propane tanks, yard waste, construction waste and loose piles.



### Please do not place plastic bags in your curbside recycling bins!

Plastic bags get wrapped around the recycling equipment and jam up the machinery. Workers must climb into the machinery to manually remove the plastic bags that get wrapped around the equipment.

### Safe Medication Disposal Box

Carroll Township has a Safe Medication Disposal box in the lobby.

**Accepted** items include: prescriptions, prescription solid or liquid medications, prescription patches & ointments, inhalers, over-the-counter medication, vitamins, and medications for pets.

**Not Accepted** items include: thermometers, hydrogen peroxide, aerosol cans, personal care products in the form of non-prescription ointments, liquids or lotions, medications from businesses or clinics, needles (sharps), bloody or infectious waste and hazardous waste.

Medications collected in the take-back box program are delivered by law enforcement to the York County Solid Waste Authority's waste-to-energy facility for safe and complete destruction. Law enforcement also maintains the box and secures medications that are received until they can be destroyed.

Eighteen York County police departments currently partner with the York County Solid Waste Authority (YCSWA) to host Secure Medication Disposal boxes in their police department lobbies. In 2022, the program safely collected and disposed of a total of 2.62 tons of unused and expired residential



medications. This program helps to eliminate drug abuse by providing a safe means of disposing of drugs and presents an opportunity to educate the public about the potential for abuse of medications.

### Retired Flag Disposal Box



Do you have a worn flag to dispose of? Carroll Township has a retired flag drop-off box located just inside the main doors. Collected flags will be given to the American Legion for proper disposal. Flags may be dropped off during normal office hours.

# DEP Can Offer Assistance with Work in or Around a Stream or Wetland


During the spring and summer months, the Pennsylvania Department of Environmental Protection typically receives a high volume of complaints from the public regarding work in streams and wetlands. Upon inspection, we frequently find a number of these activities have occurred without permits, including dredging, which is cleaning out a stream; ditching, filling in or draining wetlands; placing fill in a floodway to build up the property; relocating a stream; stabilizing a stream bank; and installing culverts, bridges, boat docks or ramps.

Homeowners, and landowners may not be aware that state, and often federal law requires a DEP permit for certain types of work they want to do on their own property within regulated waters of the Commonwealth. DEP is a resource and a partner for Pennsylvanians who are planning any activity in or around streams and wetlands, so the project can be done safely and without impacting the environment, public safety, or adjacent and downstream neighbors.

Just like the Public Utility Commission's 'PA One Call' for excavators, the best first step for homeowners and landowners is to call the local DEP office to find out what is required before any work begins. Stream work that is not properly designed and permitted can cause conditions to worsen in the next flood event, also impacting downstream neighbors. When in doubt, the first step should always be to contact your regional DEP office, DEP office staff are ready and willing to assist in several ways.

Residents, and landowners should follow these tips when conducting activities in and around streams.

- If there are low-lying, wet areas on the property where a landowner would like to fill in, consult first with the DEP Waterways and Wetlands program that serves your county.
- Removing debris from a stream channel should generally be done in a way that avoids altering the stream channel or banks, including vegetation.
- Do not mow or cut trees and shrubs along a stream's edge. This can potentially lead
  - to stream-bank erosion. If you do cut a tree down, leave the stump. Leaving a buffer along the edge of a stream or wetland is an effective way to increase a stream bank's stability, reduce stream bank erosion, increase wildlife habitat, and provide a pollutant filtering area for surface water which drains through the buffer.



• Filling, ditching, or draining of a wetland requires a permit from DEP and the Army Corps.

## **EMA Updates—Spring 2023**

All municipalities in Pennsylvania must plan for disasters as per Pennsylvania State Law Title 35 (Health and Safety) which requires municipalities to have a place, a staff and a plan dedicated to **disaster preparedness**. Our unified group consisting of Dillsburg, Carroll Twp, Franklintown, Monaghan Twp, Warrington Twp, & Wellsville is called **NEMA** (Northern York County Unified EMA) and our mission is to provide for the protection of persons & property in disasters affecting the Northern York County community at large.

### <u>Internal improvements to the EOC (Emergency Operations Center)</u>:

\*NEMA is engaged in a comprehensive evaluation of our IT capabilities with the help of a student intern from a local university and an educator who is part of our NEMA staff. Our goals for NEMA include (1) creating an SOP (Standard Operating Procedures) Manual for our staff when opening the EOC and using our equipment, (2) learning how to better communicate with York County Office of Emergency Management and (3) creating a Website for NEMA. NEMA's website is being designed for our citizens to use as a preparedness resource; we hope to have it completed by mid May 2023. We will announce it's availability through our Municipalities.

### Helping our Seniors become better prepared:

Most of our disasters in Pennsylvania are weather-related and our Senior citizens are an especially vulnerable part of our population. Power outages and mechanical failures of heating/cooling equipment can leave our Seniors in extremely cold or hot homes. There are never enough Police or Firefighters to help in emergencies and disasters; so, we must learn to help ourselves. A Plan is necessary if our Seniors need to leave their home for a short time to stay warm or cool depending on the season. The Plan must involve Family, Friends or Neighbors.



#### Start your planning by:

- a. Communicating with each other now.
- b. Determine where you will go with the assistance of Family/Friends/Neighbors.
- c. Determine how you will get there.
- d. Share your contact info and the address of the destination you agreed on with Family/Friends/Neighbors.
- e. Take only essential items- medicine, change of clothes, snack, water, mobile phone and charging device.

The Carroll Township website (www.carrolltownship.com) has excellent information on Senior Preparedness for short term emergencies where it may be necessary to leave home for part of the day.

### A Message from your Tax Collector

County/Township Real Estate and Township Per Capita taxes are mailed in February. Northern York County School District Real Estate and Per Capita taxes are mailed in July. If you do not receive your tax notice please call me.

Payments made after December 15 must be in the form of cash, cashier check or money order. Tax payments need to be in office by December 31. Unpaid personal taxes will be filed with the delinquent tax collector with added cost after December 31. Unpaid Real Estate Taxes will be liened with the York County Tax Claim Bureau after December 31.

I would like to be available when you have questions so please feel free to leave me a message. I am usually available most evenings to answer any questions. There is also an after hours drop box at the Township Building for any payments you would like to make after hours.

### **Register your Rental Properties**

The Code of Carroll Township Chapter 299 requires landlords to report the name and address of all tenants who occupy a dwelling unit within 30 days after said occupancy or 15 days after a dwelling unit has been vacated. It is the responsibility of the landlord to obtain and submit the forms to Christina Heisey, Carroll Township Tax Collector. Forms are available on www.carrolltownship.com.

### Dog Licenses are Required

State law requires all dogs over 3 months of age to be licensed. Owners of unlicensed dogs are subject to fines not less than \$50.00 and not to exceed \$300.00. Annual Licenses can be applied for in three different ways; by applying by mail or online to the York County Treasurer, and in person at a participating agent. The following is a local agent to apply in person for an annual dog license:

Annual dog license applications can also be downloaded from the website http://yorkcountypa.gov. (click on How Do I, Apply for and Dog License) and mailed with check or money order to "York County Treasurer".

Dogs three months of age or older may be licensed permanently through the County Treasurer's Office. This lifetime permanent license eliminates the need to purchase annual dog licenses. Questions regarding this procedure should be directed to the Treasurer's Office at 717-771-4386.

Other services the Treasure's Office can help you with are transferring a dog license between counties, and to a new dog owner and also replacement of tags that were damaged or misplaced.

### Logan Park Happenings

Spring is around the corner and Logan Park is looking forward to an exciting and busy season.

Logan Park continues its work to create a riparian forest buffer in the lower area of the park. Due to the drought last summer, it will be necessary to replant approximately 30% of the saplings. The saplings are being provided through an agreement with the Alliance for the Chesapeake Bay.



In addition to the park's work for the riparian buffer, Monarch Watch will be providing 30 milkweed plants to the park for planting. Growing milkweed is the most effective way to help sustain the monarch butterfly.

The interior of the barn was also renovated in 2022. The new improvements have created a multipurpose space in addition to more room for storage.

## **Highway Department Comments**

Carroll Township takes pride in keeping its roads in good condition and safe for travel. Maintaining and keeping roads hazard free is a never-ending task. The Township road projects for the summer of 2023 will include the following:

**Montadale Crest Development** – (All roads in development) Storm culvert replacement, road shoulder repair and resurfacing.

**Coover Heights Development** – (Coover and Triplett Courts) road base repair and resurfacing.

These paving projects will be taking place between June and September. Dates of the proposed work will be posted on the Township website, cable channel, and on site prior to work beginning. Expect road closures or lane restrictions for this work.

The Township Road Crew will be out and about working on various projects and maintenance of infrastructure throughout the Township. As always, please be on the lookout for the crew and use patience and caution when traveling through work areas.

For a **Pennsylvania State Highway**, you can call the PennDOT toll-free pothole hotline at **1-800-FIX ROAD** (1-800-349-7623).

In Carroll Township, Route 15, Route 74, Mountain Road, Camp Ground Road, Williams Grove Road, Harrisburg Pike, Baltimore Street, Old York Road, Mumper Lane, a portion of Chestnut Grove Road, Fileys Road, and W. Siddonsburg Road are State Roads.
